If a tenant commits a substantial breach of the residential tenancy agreement, the landlord can apply to the RTDRS or court to end the tenancy or give the tenant at least a 14-day notice to end the tenancy. The day the notice is given and the day of moving out cannot be included in the 14 days, bringing the total required notice to 16 days.

Leases and Agreements CPLEA Landlord and Tenant

The tenant can continue to live in the property until either the tenant or landlord gives notice to end the tenancy. There are different kinds of periodic tenancies, including monthly periodic tenancies (where the tenant agrees to rent month-to-month and pay rent on a monthly basis) and weekly periodic tenancies (where the tenant agrees to rent week-to-week and pay rent on weekly basis).
