If this property is an investment property, \$50,000 will be added on top of your income and will be subject to the marginal tax rate for your particular tax bracket. So, if you make more than \$103,915 a year and live in Quebec, you will be subject to an income tax of 25.75%. This means you will pay a capital gains tax of $\$50,000 \times 25.75\% = \$12,875$ on the appreciation of your property.

How to Calculate Tax Payable on the Sale of Your Rental

Similar to the calculation of capital gain tax above, we use the highest marginal tax rate of 50% to estimate the tax. Therefore, tax payable on recapture is $50\% \times \$9,500 = \$4,750$. Total tax liability = capital gain tax + recapture tax = $\$25,000 + \$4,750 = \$29,750$.
